Sl. No	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 12 of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension
2	There is some construction work is going on in the boundary wall. Thus, the school is required to complete the same and ensure that school should be bounded with concrete boundary wall (without any gap) from all sides and submit a videography link covering entire boundary wall from all sides in continuity within 03 months in the compliance.
3	The school is required to obtain a water test report of the school from a Govt. authorized laboratory within 03 months and submit the same in the compliance.
4	The mathematics lab is under stocked and temporarily arranged on make-shift tables with insufficient storage and no seating facility. Further, a workstation has been covered with a cloth, which is not appropriate. Thus, the school is required to upgrade the same as per Board's SoP within 03 months and submit the compliance.
5	The composite science lab does not have gas connection in the workstation and safety features such as fire extinguisher and exhaust fan. Further, there is a slab (workstation)

	constructed adjacent to the wall, which is not appropriate for conducting practical. Thus, the school is required to upgrade the same in light of Board's SoP within 03 months and submit the compliance.
6	The physics lab is temporarily set-up on make shift tables and chemistry labs do not have gas connection in the workstation and there are plastics stools are being used in place of wooden stools.. Thus, the school is required to re- setup the physics lab and upgrade chemistry lab with sufficient number of seating arrangement and fire extinguisher in light of Board's SoP within 03 months and submit the compliance.
7	The school is required to create a separate reading space in the library for staff and make the proper seating arrangement in the indoor games room within 03 months and submit the compliance.
8	The CwSN toilets for boys and girls are constructed next to each other, which is not appropriate. Further, it appears to be made temporarily. Thus, the school is required to re-construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit an videography covering complete proper for provision for CwSN i.e. ramp at ground level, lift to access upper and CwSN toilets in the compliance.
9	As per online application school has 02 blocks. However, in the building & fire safety certificates there is details of only one block. Thus, the school is directed to not to use the other building block for any academic activities before getting renewed building and fire safety certificate and Board's Approval and submit an undertaking in this regards on school's letterhead within 03 months in the compliance.
10	The school shall conduct training of its teachers with CoE Prayagraj within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-


1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.



If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
